#### Schedule 2 – conditions to be amended

The following conditions are amended as a result of the application made by the operator.

Condition

- **3.(a)** The location and layout drawings together with the statement of intended methods of operation contained in the document titled "Working Plan" and any later drawings or written statement received by the Environment Agency in substitution for or in augmentation of such drawings or statements, are hereinafter referred to as the "Working Plan" and give details of how operations are to be conducted at the facility.
- **3.(b)** Notification shall be made in writing to the Environment Agency of any proposed change in the actual conduct of operations from the proposals shown in the Working Plan as altered by any previously notified changes, at least one month before the proposed change is implemented.
- **3.(c)** Subject to the terms of the permit the holder shall conduct its operations in accordance with Table 1.2.
- **4.** Sufficient management and technical supervision shall be provided at the facility throughout operating hours to ensure that operations comply with this permit and the Working Plan.
- **6.(a)** The terms of this permit and Working Plan shall be made known to any person who is given responsibility for the management or control of the facility.
- 26. Asbestos waste shall be stored in the approved container, constructed and maintained as described in the Working Plan and positioned in the area prescribed. The container shall be kept sealed and padlocked at all times other than during immediate loading of the waste material into it.

#### Schedule 3 – conditions to be added

The following conditions are added as a result of the application made by the operator.

**39.** The operations specified in table 1.1 shall not commence until the measures specified in that table have been completed.
